The documents have to be addressed to Belpex in English, except as regards official documents available in Dutch or French.

4. Forms

The forms provided herewith which have to be filled out by the Participant are:

- The Participant Contact Information Form.

For the application file, the duly filled out forms must be annexed to the Participation Agreement.

5. Changes to the forms

Changes to the representations made in the Application Form shall be notified in writing to Belpex in accordance with Article 9 of the Market Rules.

Changes to the information contained in the Authorized Representatives and Authorized Users Form or in the Participant Contact Information, whether during the application procedure or during the course of the Participation Agreement, shall be notified to Belpex in accordance with Article 9 of the Market Rules by submitting the relevant form duly filled out with the new information.

Any modification to information contained in a form shall take effect as regards Belpex on the fifth (5th) Business Day following Belpex' receipt of the notification thereof, unless otherwise agreed.

In case several Authorized Users have been appointed by means of the same Authorized Representatives and Authorized Users Form, separate Authorized Representatives and Authorized Users Forms must be used (one per Authorized User) for the termination of the Access of several Authorized Users or modifications of several Authorized Users.
